**1. Narrative/Overview Narrative By Megan Wirt**

On August 25, 2021 I was notified by booking supervisor Dustin Ceder that an inmate had broken several sprinkler heads throughout the morning. He advised Steven Pleas broke sprinkler heads in three different locations. First, he broke the sprinkler in G-Pod in cell G-1, second in G-2 and third in the isolation cell. He was then moved down to the
