## **1. Narrative/Overview Narrative By Travis Healy**

On Sunday, July 3, 2022, I, Deputy T. Healy was on duty for the Pottawattamie County Sheriff's Office. I observed a white 2006 Pontiac Torrent traveling northbound on Chautauqua Avenue.
