1. Narrative/Overview Narrative By William Bates

S22-001548 Traffic stop arrest

On 8/16/22 at 0930 hours, I Deputy Bates, conducted a traffic stop in the Casey's General Store parking lot in Crescent, Iowa for expired registration on a travel trailer camper being pulled by a Black Ford F150 pickup. Upon smelling the odor of Marijuana coming from the vehicle 2 subjects, a Ashley Blank and a Justin Landon were detained. I Deputy Bates did find drug paraphernalia and marijuana inside the vehicle which lead to the arrest of both Ashley Blank and Justin Landon. Additionally, a Conservation officer arrived on location and had Ashley Blank charged with a camping violation, as the subjects didn't pay for 2 days of camping at the Hichcock nature center. Both subjects

were transported to the Pottawattamie county jail. While in the jail, staff did find Methamphetamine inside Ashley's property.

Ashley Blank is being charged with Possession of Drug Paraphernalia, Possession of marijuana, Child Endangerment, and Possessing Contraband in a secure facility as well as 2 counts of Camping Violation on Public Lands. Ashley was also cited for the expired registration on the travel trailer. It was discovered by jail staff at the jail facility that "Justin" was indeed a Michael Gene Landon, and had provided Deputies with a false name.

Michael Gene Landon is being charged with Possession of Drug Paraphernalia, Possession of marijuana, Child Endangerment and Providing False Information .
